## DIRECTIONS -

I-91 North: Take Exit 13 ("Industrial Exit – North Haven, Rte 5"). Turn right off exit ramp onto Route 5. Follow Rte 5 to 5<sup>th</sup> traffic light – you will be in the center of downtown Wallingford. Turn left (after gazebo) onto Hall Avenue; Go over railroad tracks to 2<sup>nd</sup> traffic light and turn right onto Washington Street. At first stop sign, turn left into Senior Center parking area.

Rt. 15 North Take Exit 65 (Rte 150, Yalesville). At end of exit ramp, turn left to traffic light. At traffic light, turn right onto Hall Avenue. At first light, turn left onto Washington Street. At first stop sign, turn left into Senior Center parking area.

I-91 South Take Exit 17 for Wilbur Cross Parkway South (Rt 15). Take Exit 65 (Rt 150, Yalesville). Turn left at end of exit ramp. At 3<sup>rd</sup> traffic light (do not count the light in front of the fire station) turn left onto Washington Street. At first stop sign, turn left into Senior Center parking area.
